If your application for membership is rejected by the Committee, you may give notice of your intention to appeal within 14 days of being advised of the rejection (rule 5(4)). The Group in a General Meeting, no later than the next Annual General Meeting, must confirm or set aside the decision of the Committee rejecting your application, after giving you a reasonable opportunity to be heard or to make written representations to the General Meeting (rule 5(5)).
